## Federal Policy Update – JAN 2025

Telehealth Flexibilities: Congress passed as part of the December 2024
Continuing Resolution a provision that extends most of the COVID-era
flexibilities for telehealth appointment reimbursements until March 31,
2025. Not extended and now expired are provisions allowing first dollar
coverage for telehealth appointments paid by Health Savings Accounts
or High Deductible Health Plans.

# CMS Update- JAN 2025 (Alan Constantian Covering Uche Anaeto's beat)

- Important News Since Last Report:
  - Dr. Mehmet Oz nominated by President-elect Trump as CMS Administrator.
  - Marketplace enrollment reaches 23.6M consumers for 2025 coverage as of Jan 4, 2025, a jump from the 20.4M consumers covered in 2024. Marketplace enrollment ended Jan 15, 2025 for coverage in 2025.

## ONC Update- JAN 2025 (Keerti Resapu Reporting)

- Important News Since Last Report:
- The ONC was restructured as the Office of the Assistant Secretary for Technology Policy (ASTP) in mid-2024, taking on a broader mandate to lead technology, data policy, and strategy initiatives across the Department of Health and Human Services (HHS). The ASTP will continue implementing the HITECH Act and 21st Century Cures Act while driving efforts to improve interoperability, enhance patient access to health data, and modernize health IT infrastructure. The role was also assigned as the interim AI lead for HHS.
- Micky Tripathy, Ph.D. serves in a political appointment but one which does not require Senate confirmation. Therefore, he would be expected to submit his resignation and have it accepted by President Trump following the latter's inauguration.
