HIMSS Advocacy Priorities

1. Advancing cybersecurity measures for healthcare

- a. Funding for prevention, risk management, analysis, and mitigation
- b. Education programs to expand the cybersecurity workforce
- 2. Responsible use of AI in healthcare focusing on key areas:
 - a. Policy Guardrails
 - b. Feasibility Testing and Equity Bias Mitigation
 - c. Clinician and Consumer Trust
 - d. Human Oversight
 - e. Data Harmonization
- 3. Digital Health Transformation to include necessary funding and technology distribution, particularly to support patient care
 - a. Telehealth and Remote Patient Monitoring
 - b. Broadband expansion
 - c. Equitable policies that advance the safe, affordable, and ubiquitous adoption for medically underserved populations

4. Public Health Data and System Modernization

- a. Proper funding and workforce development to ensure Public Health is an equal partner with traditional clinical care
- State, Territory, Local and Tribal (STLT) health entities require a significant investment to maintain the software, hardware, workforce, licensing sustainably, and technical support to transmit vital health data electronically to public health agencies.

Federal Policy High Interest Item – FEB 2025

Telehealth Flexibilities: Congress passed as part of the December 2024
 Continuing Resolution a provision that extends most of the COVID-era
 flexibilities for telehealth appointment reimbursements until March 31,
 2025. Not extended and now expired are provisions allowing first dollar
 coverage for telehealth appointments paid by Health Savings Accounts
 or High Deductible Health Plans.
